# POLICIES AND FEES

## SECURING APPOINTMENT

### DATE:

Your appointment date(s) and service(s) will be secured when the signed contract, \$100 scheduling fee, and deposit have been received. All bookings for weddings are made on a “first-come-first serve” basis. No dates will be guaranteed.

### CANCELLATIONS:

We require a two-week (14 days) notice of cancellation. If an appointment is canceled less than two weeks (14 days) before your appointment, your deposit will be forfeited. If a cancellation is made within one week (7 days) or less, your credit card will be charged for the total cost of services. Should any party member forego a prearranged service on the date of the service, the original service charges will still apply. Cancellations due to emergencies or unforeseen circumstances are considered on a case-by-case basis and are completely at the management’s discretion.

## SERVICE PAYMENTS:

Your remaining balance can be paid with a card or check on the day of your wedding or in advance with bridal permission. If you wish to use a check, you must do so one week (7 days) in advance of the reserved date. A 18% gratuity will be automatically applied to your final service cost. We DO NOT allow individual payments on the day of the wedding. The remaining balance must be paid on one card or by check. The bride and bridal party are responsible for arranging a payment system before the wedding day.

## CONTRACT AND

### APPOINTMENT CHANGES:

Any changes/additions to guests or wedding party members requesting additional services after the contract is signed must be submitted in writing via email (no changes made over the telephone). Changes will be accepted up to 14 days before the service date, although adding additional services may not be guaranteed. The bride signing this contract or the Bride’s Contact Person is the only person permitted to authorize, submit, and change any arrangements for the wedding party.

# POLICIES AND FEES

## LATE ARRIVALS:

If the wedding party is more than fifteen (15) minutes late, the party will be charged an additional \$15.00 for each of the late guests. Tardiness results in scheduling and service conflicts for you and other clients following your appointment(s). If the scope of the original contract cannot be fulfilled due to the client's tardiness, services may be reduced; however, clients are liable for the original amount. If a wedding party is more than 30 minutes late, the assumption will be that the party is a "no-show". This will result in the client forfeiting all deposits and your credit card will be charged 100% of the total services.

## SPRAY TAN POLICIES:

Spray tan services are subject to availability and must be booked in advance. Trial Spray tans are required for the bride to ensure desired results. Fusion Salon and Spa is not responsible for results affected by improper pre or post-care, including but not limited to exfoliation, shaving, sweating, water exposure, or skincare products used outside of Fusion's recommendations.

## ESTIMATED COST:

The estimated cost is based on the initial services requested. Additional charges will be included should a member of the bridal party request services that were not initially quoted.

Bridal Party Pricing Information:

The Bride MUST do a hair and makeup trial. If you would like to include a spray tan, a trial is required as well. Bridal prices are bundled to include both the trial and the day of services. A \$100 scheduling fee is automatically applied to all bridal parties. A 15% gratuity will be automatically calculated into your final cost of service. Strip lashes are included in all makeup applications. If your party wishes to do a trial, they are the same price as the day of.

Important: **The Bride MUST do a hair, makeup, and spray tan trial.** We will schedule the trial at the time of the deposit. We recommend scheduling 4-6 weeks ahead of the date of the wedding. Please arrive on time for your service(s). Wear a zipper or button-down shirt. Bring all the hair accessories you wish to use, including the veil. When receiving makeup services, please arrive with clean skin. When receiving style services, arrive with your hair dry and preferably shampooed the day prior. (An additional \$15 blowout fee will be charged if you arrive with wet hair.
